

COLLECTION SYSTEMS AND FINANCIAL SUPPORT

To ensure the recovery and recycling rate established by law is reached, Valorlux's model is based on:

- Door-to-door collections (Valorlux blue and green bags)
- The RE-box
- Financial support
- Recycling centres



BLUE BAG - COLLECTION EXTENSION: A PILOT PROJECT TO COLLECT AND RECYCLE MORE PLASTIC PACKAGING

From January to November 2020, 48 municipalities participated in a pilot project aiming at collecting additional fractions of plastic packaging in the blue bag.



RE-BOX

In 2020, 58 tons of packaging waste were collected using 16 RE-Boxes spread across Luxembourg.

FINANCIAL SUPPORT

Valorlux provides financial support for packaging waste collections all over Luxembourg, an example being door-to-door collections of paper and cardboard, organised by local authorities, consortia and associations of communes. This type of collaboration involves paying a set amount for each tonne of packaging given to accredited recycling companies.

In 2020, Valorlux provided financial support for the collection of 37 161 tons (59,35 kg/person/year) of packaging waste.

RECYCLING CENTRES

In 2020, the amount of packaging waste collected by recycling centers was 4 140 tons or 6,68 kg/person/year.
